

- d. Those candidates who have already gone through Apprenticeship training in any organization are not eligible to apply.
- e. The apprenticeship training is for fresher's only. Those who passed the course before three years (i.e. before 2017) are not eligible to apply for apprenticeship training. In other words, the gap between the date of declaration of results and date of recruitment should not be more than 03 years (copy enclosed).


 As such only, pass out candidates who have completed the degree/ diploma courses on or after 01.01.2017 are eligible to apply.


