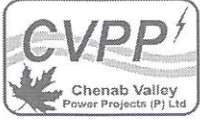

- 2. Reservation & Relaxation:** Reservation and Relaxation shall be as per the provisions of The Apprentices Act, 1961 and the Rules framed thereunder as amended till date.
- 3. Employment in CVPPPL:** Candidates shall have no claim whatsoever as to any extension of Training and/or employment in CVPPPL.
- 4.** Only those candidates who are domicile of J&K are eligible to apply.

- The eligible candidates will be shortlisted on the basis of marks secured in 10th class/ITI. The shortlisted candidates can be called for interview if required and offer will be sent through portal/ e-mail. The list of the selected candidates will be uploaded on the website of CVPPPL i.e. www.cvppindia.com
- The candidates shortlisted shall have to produce all original testimonials / certificates such as educational certificates, ITI marks sheets and certificate, caste certificate, Domicile certificate, issued by Competent Authority, Aadhar Card etc. at the time of verification. In case any information / claim made by the applicant in his / her application is found to be false, the candidature of such applicant shall be cancelled and action as per rules will be taken.
- The candidate will have to submit Medical Fitness Certificate issued by the Competent Authority (Govt. Estt.) at the time of joining.
